The following actions were taken based on the suggestions given by the members

Suggestion 1

Mangalore University has made NCC as an Open Elective Subject. It is helpful for the students for Employment Opportunities. And in the beginning Directorate General of NCC (DG NCC) have made a syllabus for 3 years later when NCC is made as an Open Elective Paper. The Syllabus which was made earlier has not been Updated or Changed. And still no updated syllabus for 2 years has not been released by Directorate General of NCC (DG NCC). As a result of it Our College made a Syllabus compressing the previous 3 years degree syllabus. Some Initiations must be taken at State government level to make NCC as more effective subject.

Action Taken

As the Decisions are to be made by the Govt level. We will follow up with the newly made syllabus till the updated syllabus is been given from the DG NCC.

Suggestion 2

Lt. Bhanu Prakash suggested that the syllabus should include practical aspects in curriculum. So that the subject can be made more interesting. Practical aspects such as Firefighting, First aid, Weapon handling etc. And suggested to conduct 2 hours of Theory and 1 hour of Practical oriented classes.

Action Taken

As the practical oriented topics are already included in the syllabus the students will be given practical knowledge while conducting classes during class hours.
