


Chart 1: Opinion on Industrial exposure of the syllabus


**Chart 2: Opinion on Global relevance**


Chart 3: Opinion on number of teaching hours


Chart 4: Opinion on sufficient reference in the library


**Chart 5: Opinion on evaluation methods**


Chart 6: Opinion on syllabus meeting values, skills, knowledge


Chart 7: Opinion on relevance of the syllabus to professional development






Question wise report Analysis

Question 2: Syllabus has a good balance between theory and practical aspects
















### Chart 1: Opinion on planning of academic activities




Chart 3: Opinion on coverage of contents within specified hours





Chart 4: Opinion on reference materials available in the library




**Chart 5: Opinion on evaluation pattern**




Chart 7: Opinion on professional development in future
