2. Both parties jointly agree to develop and establish provisions for program implementation that will serve the mutual interests of each institution.

3. It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supportin--*g the exchange and collaboration. The contract and exchanges between the two parties shall be on the basis of friendship and mutual assistance.
