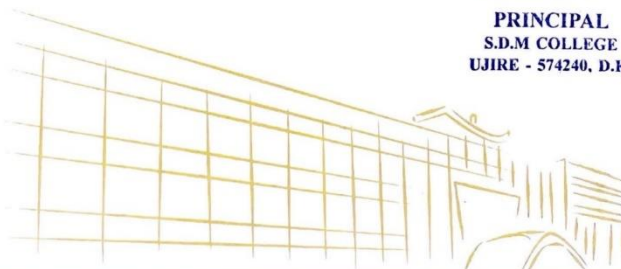

After receiving the complaint, the chairperson shall convene the meeting of the cell. The chairperson will appoint investigation committee, coordinator will convene the meetings.

On the completion of any inquiry, the investigation committee submits a report of its findings to the cell and it will be submitted to the Principal for the necessary action. The final decision will be taken by the Principal. The person who is found guilty will be punished depending on the seriousness of the complaint.

The college has zero-tolerance to sexual harassment. In the beginning of the academic year itself "Sexual Harassment at workplace (Prevention, Prohibition and Redressal) Act 2013" will be displayed in the campus and hostels to ensure a safe and healthy environment for fresher.

The college has a transparent mechanism to address the grievances of students. A student can give a formal representation to Student welfare committee directly or through mentors

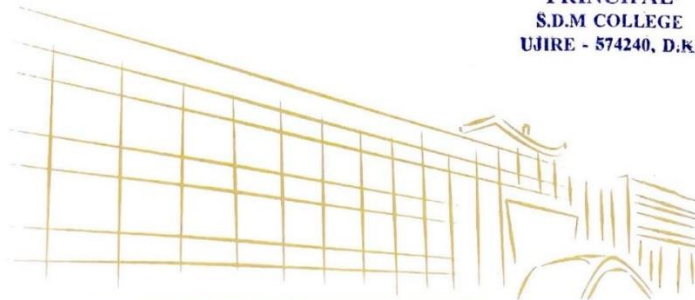

The student Forum Meet is attended by the student leaders and grievances are represented to the Principal through Chairman of Student welfare committee. Grievances must contain the student's name and class and a statement regarding grievance or complaint. Upon receipt of the formal grievance from the student, the Principal shall review the grievance along with the Student welfare committee members whether the grievance is within the limits of the Student grievance procedure and assess the facts if true or not and take necessary steps to redress the grievance on time

If the Principal determines that a complaint is genuine, timely and will arrange for corrective measures. The final decision is taken by the Principal.

The college has zero-tolerance to ragging cases. In the beginning of the academic year itself Anti-ragging regulations will be displayed in the campus and hostels to ensure a safe and healthy environment for fresher. The students can meet the Principal personally and convey their grievances if any also.

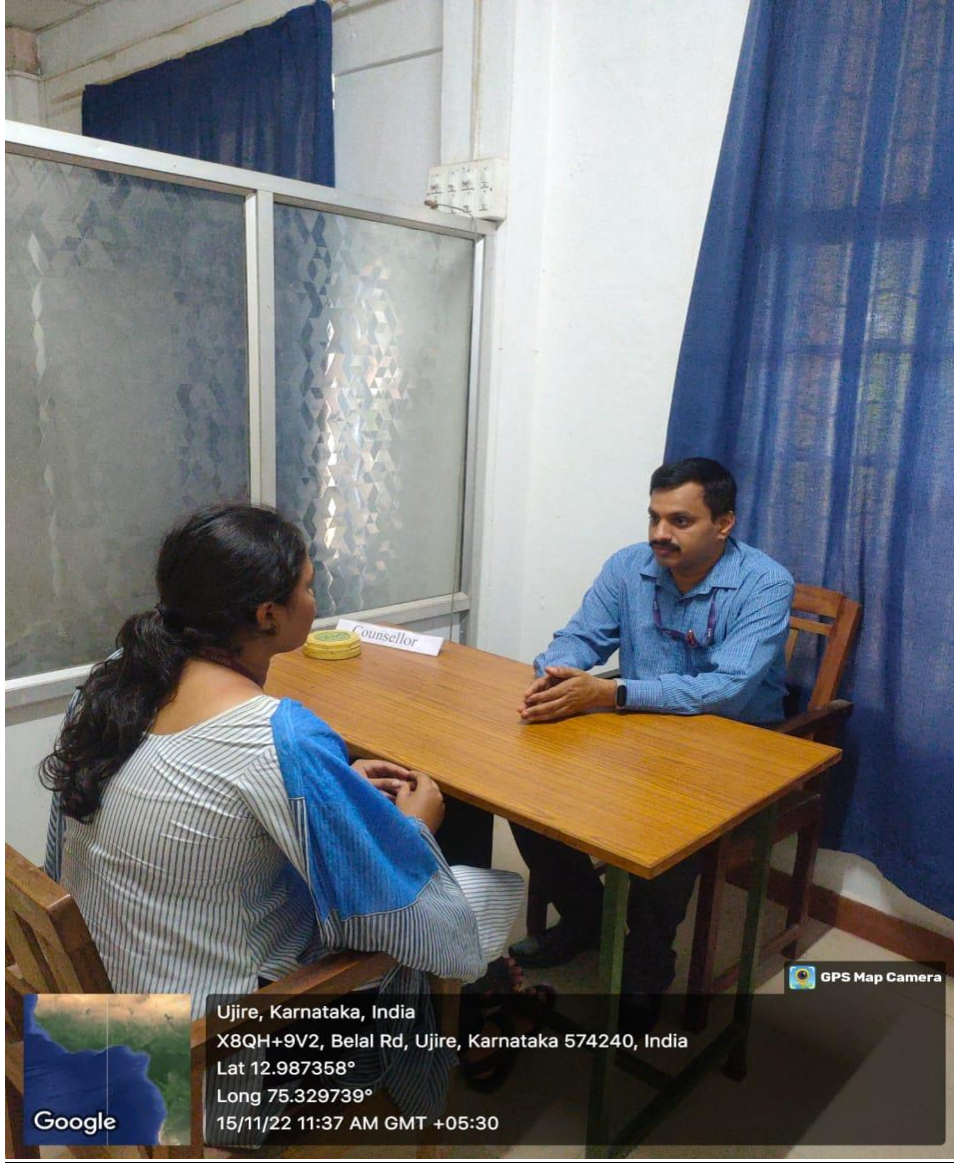
