

Chart 1: The academic plan given in advance helped me to plan my academic activities





































Chart 1: Contents of the syllabus are relevant to the course.









Chart 3: Syllabus provides comprehensive knowledge and perspective in the subject area.





Chart 5: Current syllabus adequately covers contemporary topics/global issues/emerging global and national trends in management.





Chart 6: The specified contact hours stated in syllabus is sufficient to complete the syllabus.





Chart 7: Sufficient reference materials and books are available in the library for the topics mentioned in the syllabus.







