













In the open-ended space provided for students to give feedback, the students have also mentioned that they would like more equipment to be available at the department for filmmaking activities and for them to have more field visits.



















Conclusion


















The overall conclusion from the feedback taken from alumni of the department is that the syllabus caters well to the requirements of the professional field as understood by the alumni who have graduated from the department.










