





- 5. A certificate that the organization has not received any grant from State or Central Govt. or from any other agency for the same proposal.
- 6. Undertaking for maintenance for 10 years from the Competent Authority and also mention that proposed land not to be diverted for any other purposes.

- PI should focus on RET, endemic medicinal plant species and re-submit the revised list of medicinal plants species based on agro- climatic condition of the proposed area.
