

- Undertaking for maintenance for 10 years from the Competent Authority and also mention that proposed land not to be diverted for any other purposes.

- PI should focus on RET, endemic medicinal plant species and re-submit the revised list of medicinal plants species based on agro- climatic condition of the proposed area.
- 10. Given that the area is in the Western Ghats and home to rare species the PI was told to remove common medicinal plants from the proposed list example Bacopa monnieri and focus on species which need to be conserved.
