
The committee discussed about the chances of commencement of offline classes to have contact with the students. As there was no other issues the meeting ended at 4:45 pm.


The committee agreed to get the questions ready and submit it to the campus audit committee. The meeting ended with the vote of thanks by the Co-Ordinator.
